You are about to create an account in the GEPVISION tool and you will be subject of the Rights and Conditions specified below.

#### PEOPLE WHO CAN USE THE GEPVISION TOOL

The GEPVISION tool is intended to be used by the staff members of the partners of the project "ATHENA - GEPs experiences for improving gender equality in research organisations". They are people who have reached the age of legal majority in their jurisdiction, i.e. the age at which an individual is recognized by the applicable law to be an adult and responsible for any legal obligations created by his or her actions.

#### ABOUT THE ATHENA PROJECT

The project "ATHENA - Implementing gender equality plans to unlock research potential of RPOs and RFOs in Europe" is an Horizon Europe project funded by the European Commission, Grant agreement ID: 101006416.

# DATA CONTROLLER, DATA PROTECTION OFFICER AND RESPONSIBLE FOR DATA PROCESSING

#### PERSONAL DATA PROCESSING AND STORAGE

The GEPVISION digital Tool developed, configured and provided by IRPPS-CNR, and managed under the responsibility of Patrizia Grifoni, Chiara Bicchielli, Noemi Biancone and Fernando Ferri. The tool is managed with the secure communication protocol HTTPS. It is installed on a server hosted in the CNR server farm in Rome and managed by Chiara Bicchielli and Noemi Biancone. All data are stored and managed in a fully compliant way with the EU General Data Protection Regulation (GDPR).

Data processing will be fully compliant with the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27th 2016 on the protection of natural persons with regard to the processing of personal data and the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) and GDPR.

#### TYPE OF PERSONAL DATA THAT WILL BE PROCESSED

Personal data that will be processed will be:

- All data that you provide to us when you get registered (first name, family name, e-mail, organization, Country, address of your organisation)
- All data that you provide to us when making your request, or when you are using a service.
- Those additional data that you provide to us during the processing and management of a service, together with those relating to the other data handling processes described in this document, provided that you have given us your consent, or for whose processing we are otherwise authorised in accordance with the prevailing legislation.

You promise to provide true and updated personal data.

The IT systems and procedures used automatically acquire, during their normal operation, some personal data relating to the navigation of the interested party such as: the IP addresses of the computers used by the users who use the service; the number of accesses; the pages viewed; the date and time when the access took place.

#### PROCESSING FOR MANAGEMENT PURPOSES:

CNR-IRPPS will process your personal data to manage your requests and services provided in ATHENA related to the monitoring of GEPs, the data collection within the organisations that are implementing the GEPs and their staffs in ATHENA, and the collection of data from the consortium members, for collecting the RRI adoption in the project life.

CNR-IRPPS is authorised to perform the aforementioned processing of your personal data since it is necessary to comply with the ATHENA activities and your request.

#### WHAT HAPPENS TO THE INFORMATION YOU PROVIDE?

We do not collect any personal data, except for contact persons that each partner of the ATHENA project who will be appointed to manage data collection for her/his GEP. These personal info contains Name, Family name and e-mail. These row data will be managed, only by CNR-IRPPS and will not be shared with other organisations. The information you provide will be used for progressing tasks in ATHENA and will not publish these data with information which identifies you personally.

Data processing does not involve automated decision-making processes (such as profiling).

#### PERSONAL DATA ASSIGNMENTS TO THIRD PARTIES

CNR-IRPPS will not assign personal data to third parties without obtaining your prior consent, except for those required to comply with the legal obligations.

### **DATA RETENTION PERIOD**

Data will be retained till the closure of all the activities of the ATHENA project foreseen in January 31<sup>st</sup> 2025.

#### **COOKIES**

The GEPVISION tool does not use any cookie.

#### **RIGHTS**

You have the right to ask the data controller 1) for accessing to personal data and 2) their correction or cancellation or 3) the limitation of processing that concerns them or to oppose their processing. The interested party has the right to present his / her request to the Data Controller. Instances can be sent

You also have the right to lodge a complaint with the supervisory authority.

You can withdraw the consent granted, and exercise your rights of access, rectification, elimination, portability, limitation and/or opposition to the processing at the following e-mail address:
